#### **NOT Permitted:**

- 1) Any Non-Narcotics Anonymous Related Function
- 2) Non East End Area Events unless Co-Sponsored by the East End Area
- Group Conscience Dates/Time Changes/Format Changes/ Location Changes, etc. (These should be submitted through PR Committee or addressed at AREA by your GSR))
- 4) Events which are in Violation of N.A. Policies, Traditions & Concepts

#### How to Post an Event:

Please use the attached EEASC Calendar Event Posting Request Form (See Back of this Page) to submit your event using 1 of the 2 methods below.

METHOD 1: Using the EEASC CALENDAR EVENT POSTING REQUEST FORM as your Guideline, you may submit your event via e-mail at <a href="www.eeascna.org">www.eeascna.org</a>. 
