## Nov and Dec Treasurer Report 2014

Hello Family

As you all know we technically were without a treasurer in November, but thanks to AJ we were able to collect donations in the amount of 651.81 which was deposited into the ASC account, since we had no treasurer no checks were written and the only expenses were 30.00 for Metro PCS. I have attached a spreadsheet illustrating these transactions.

In Dec I was elected treasurer and it is an honor to be able to continue to be of service to this area and our fellowship. In Dec donations were collected in the amount of 473.86, which was deposited into the ACS account. Check numbers 1339-1343 were written totaling 1080.79, since then all checks written have cleared except for \# 1342, which was a void due to my poor penmanship. CellDARA and Metro PCS were paid electronically totaling 89.00 for a total in expenses of 1196.79.

I have attached a spreadsheet illustrating these transactions. There is also an outstanding check for 250.00 which was written in Sept as a regional donation which had not cleared as of our last meeting so the amount that I suggested as a donation was based on the money that was in the account at that time not what was accounted for, so I asked AJ to hold off on cashing that check until we could sort out whether or not the bank account could sustain both donations and still remain at or above prudent reserve.

Year End Treasurer Report 2014

Since taking over as treasurer I have spent several hours pouring over the last years treasurers reports, bank statements, there were a few discrepancies many of which were simple accounting errors and misreporting mistakes each of which were cleared up and fixed and I am grateful to say that every dollar has been accounted for and properly reported. In 2014 donations were collected and deposited into the ACS account in the amount of 6944.41. Total expenses for 2014 were 6066.46. I have attached spreadsheets illustrating these numbers, including exact figure of where each donation came from listed by group and where each expense was outlaid listed by category and position.

I have also attached a Budget v/s Actual report and according to that we were under budget for the year by 2680.94, but it should be noted that we were also budgeted to spend 1802.99 more dollars than we collected in 2014. It should be noted as well that the 2015 budget that was sent out in your minutes had an increase of 120.00 when compared to 2014. This

increase has also in turn increased or prudent reserve to My reason for pointing this out is one of two things has to happen either we need more donations or we need to shrink our budget to more accurately reflect our actual income. In the mean those position with budgets please be mindful that just because you have money available to use does not mean you have to actually spend it.

I have also transitioned the accounting from the slow and outdated computer into a google doc spreadsheet, which works the same way as excel but uses cloud storage and therefore its technology will continue to be updated to match the current environment. I think this will create the space for more to serve in this position since all one will need is a internet connection and training and will not be based on owning or being responsible for equipment, which will also still be available as needed and if necessary. I am actively searching for an alternate treasurer in hopes of not having to hold this position any longer than necessary simply because we have no one available and trained to take over the position, so if any of you know anyone who is willing to learn I am willing to teach.
