To East End Area Trusted Servants,

Jeremy and I did an audit of the books this morning by phone, and so everything is correct and matches the Feb. bank statement, and the checkbook is balanced. Jeremy will also meet with me and Cheri this month to help us get familiarized with the spreadsheets app. Since our last meeting we received \$ 1190.67 in group donations which were deposited into the Area's checking account. During Feb. statement period the Area incurred \$119.95 in expenses. The beginning balance for statement period beginning 02-01-16 through 02-29-16 was \$1373.48 and the ending balance for this statement period is \$2444.20. We currently have funds above prudent reserve in the amount of \$981.08. The amount of the Region donation that Fred will be taking this month is 700.00.

Jeremy met with myself and Cheri H. our new Alt- Treasurer at the Wells-Fargo bank and Jeremy's name was removed from the checking account. My name and Cheri's were added as signatories. I have received the checkbook, receipt book and archives of the Area's treasurer records. Jeremy, Cheri and I plan to meet during March so that we can familiarize ourselves with the spreadsheet application and go over the Area's financial policy.
