The statement on the following pages was read by Sisters in Unity and supported by NA Vaders.

Our homegroup, Sisters in Unity, would like to address the service body in regards to the events that have happened recently here at the ASC meeting. We hope that this will be received with open-mindedness and patience and willingness to listen and to change.

First, we are concerned, that at last Area Service, the 10th concept was misunderstood. Our 10th concept states "Any member of a service body can petition that body for the redress of a personal grievance, without fear of reprisal." The definition of redress is 'to remedy, or set right.' That means we want to find a solution. Grievance is defined as 'a real or imagined wrong or other cause for complaint or protest, especially unfair treatment.' The definition of reprisal is 'an act of retaliation.' We feel the way the last ASC was handled in response to Sisters in Unity's concerns was unacceptable. Our Homegroup's concerns were mocked and members were ridiculed personally. We see these as acts of retaliation. Our Homegroup brings these concerns to the floor, not to focus on the problem, but to offer solutions. As a body, we should all remember to place principles before personalities. And most importantly, we have in common, our fellowship's primary purpose - to carry the message to the addict who still suffers.

Our second concern is in reference to effective communications. The Eighth Concept states "Our service structure depends on the integrity and effectiveness of our communications." We feel that some of the responsibilities for the RCM are not being fulfilled properly. Our policy states in Article 5, C., G., 2. a)

The primary responsibility of the RCM is to work for the good of NA as a whole by providing communication between our Area and the rest of the Georgia Region of NA. Our RCM is the East End Area's Fellowship link with the Regional Service Committee. The RCM provides communication between these service levels and the various Groups within the Area and other areas.

There have been at least three instances where the RCM either did not bring back needed info, or reported misinformation from the Regional level.

- The first instance was in October and November in 2018. Nine topics were introduced at the Regional level, but only 3 were to be brought back to the Area level. The three topics the RCM listed in his report included two that were not to be taken back to groups. This miscommunication created confusion and unneeded discussion, not only at the ASC, but at the homegroup level as well. A trusted servant with knowledge of Regional business was present at that ASC to redirect the conversation and focus on the three correct Topics that were to be taken back to groups. This was followed up with an email including the November 2018 ASC minutes and Regional Topics to be voted on.
- The second instance was in May 2019, when the RCM sent an email stating "Nomination for Regional Delegate was awarded to the current alt. Chair (Big Bob) and David W. from mid-town is nominated for 2019 alt chair, please send a vote back concerning the Alt. position." This statement was incorrect, since Bob D. didn't take over the position and still needed to be voted in, per Region Policy. This would be the case at Region, as well as in East End.

The third instance was at the last ASC, concerning the approval of the Region's 2019-2020
 Budget and Region's 2019-2020 Policy. The RCM reported to our GSR's that the Region's budget was already approved. Region's Budget and Policy would never be approved without going back to the Area and to all our East End homegroups. Fortunately, this error was caught in time and the RCM and RCMA worked together to remedy the situation.

While all three of these instances did work out in the end, our homegroups deserve to have information that is correct, consistent, and timely, so we can make informed decisions.

Article 5, C., G., 2, c) states the RCM is a source of information and guidance in matters concerning the Twelve Traditions and the 12 Concepts.

Sisters in Unity's group conscience is that the RCM has not been fulfilling this duty and that the Eighth and Tenth Concepts haven't been followed during the ASC meetings.

We want the ASC to hear our concerns, but we also want to offer solutions and hope that they can be carried out. We would like to have the RCMA practice his duties as well.

Article 5, C., H., 2, c) Assist RCM in the performance of all duties.

The RCMA can get ready to move up into the RCM position by taking lead at the next two RSC meetings, ensuring not only that we will receive all needed info, but also being confident that he will be able to take over next June. Our end goal is for East End Area to have the best communication we can with the Georgia Region.

Lastly, we would like to remind everyone of the Second and Sixth Concepts.

The Second Concept states "The final responsibility and authority for NA services rests with the NA groups."

The Sixth Concept says that "Group conscience is the spiritual means by which we invite a loving God to influence our decisions."

The homegroups, not the Area Service Committee positions, or Subcommittees, have the final say in what we do as an Area as a whole. The homegroups have the voting rights. We have the choice to choose who we want to serve in these positions. We also have the choice to remove anyone from these positions. Our Area deserves to have servants that want to follow principles and want to serve to make NA better as a whole. There is no room for personal put downs, disrespect, arguing, cursing, yelling, or any other negativity at the business meetings. East End Area has had trouble finding trusted servants willing to come here and serve at this level because of this. It is important to carry an atmosphere of recovery not only at our regular meetings, but at the ASC meeting as well, so we may focus on our primary purpose. Our homegroup is committed to serving the needs of the addicts who still suffer.

Thank you for allowing us to share.


