The EEASC is a Committee made up of Group Service Representatives (GSRs), special purpose Task panels and an Administrative Body from Member Groups of the East End Area.

Regional GRC, INC. Report

I am very Pleased to report to you the GRCNA 40 was a Huge Success. We replenish our cash to continue carrying the lifesaving message to addicts in the Form of H & I, Public Relations, and a Yearly Convention for Recovering Addicts in the Georgia Region. I'm so excited to announce we have added 3 BOD members to our group since we left the convention in May. The CPP is very excited about the upcoming convention, GRCNA 41. So, we have decided to re-sign the Contract with the Crowne Plaza. We feel that with the situation of the economy, the offer that we relieved from the venue, that at least for now, GRCNA will probably negotiating contracts 2 years at a time. I realize this is unorthodox for our region. Please, understand that we did not make this haphazardly make this decision. Please continue to support GRCNA.

I have a huge apology to make. Most everyone that attended GRCNA 40, you realize that we never showed an In Memoriam video at the convention. It is My Fault. The video was produced, We simply forgot to do it while all the moving parts were being exercised. IT IS NO EXCUSE. Please try to forgive me, There were a couple of personal friends in that list, so trust me when I write, It hurt my feelings to.

So GRC Inc, will be changing its tax status to a 501 C3 in September, at least these are our aspirations. We have also agreed to recreate the CFO position on the Board of Directors. We will be updating Our By Laws and Roles and Relationships shortly.

I have not had the opportunity to get the financials to the secretary, The financial quarter ended May 31st, 2022. Today we currently have \$36,867.44 in the Checking account. We hold 3 CDs of \$5,000 apiece. So, we feel like we probably brought in about \$44,000 in all our efforts. We did have a loss last year of \$6,000.00. Remember, the MARRIOTT situation. We also spent money on ASL interpreters close to \$800. But all, in all, We had members from every area attend GRCNA 40. Thanks for your support.

The RSC H&I Subcommittee serves the needs of all the areas within the Georgia Region by conducting quarterly panel meetings and hosting activities that promote the growth and strength of all H&I efforts and needs within the region and the fellowship.

We hosted a fun and information workshop at GRCNA with great participation and engagement from all.

The subcommittee is currently in need of a SECRETARY and CO-CHAIR, please see service descriptions below:

SECRETARY – Term is 2 Years

1. Is elected by H&I subcommittee / Biannually in June
2. Must meet clean time requirement of 1 year
3. Must have at least 6 months experience in regional H&I work and a working knowledge of the twelve steps, twelve traditions and twelve concepts through application
4. Must have a certain amount of clerical skills
5. Must keep an accurate set of minutes of all H&I subcommittee meetings and learning sessions (topics discussed). They should be ready for distribution to all Area H&I Chairs within 14 days from Regional meeting
6. Works with the chairperson to ensure the smooth operation of the H&I subcommittee
7. If necessary, may be removed by a vote of the subcommittee

VICE CHAIRPERSON – Term is 2 years

1. Must meet clean time requirement of 2 years
2. Is elected by the H&I subcommittee / Biannually in June
3. Must have at least 1 year experience in regional H&I work and a working knowledge of the twelve steps, twelve traditions and twelve concepts through application
4. Attend meetings of the subcommittee as standard practice
5. Works with the chairperson to ensure the smooth operation of the H&I subcommittee
6. Performs the duties of the chairperson in their absence
7. If necessary, may be removed by a vote of the subcommittee
8. Submit quarterly report

Our meeting today had 8 areas represented. Given the turnover of service it is vital that we have the help of the area RCMs to communicate to your h&i chairs that we are meeting and please ensure that an updated contact (if the position is vacant you can provide yours) is sent to handi@grscna.com. This will ensure meeting invites and minutes are sent. All 8 areas are serving facilities at this time, most more than 1, which is a great sign of the return to facility access.

There are some wonderful collaborations happening around our state as well... the Midtown area and North Atlanta area are collaborating on serving the Dekalb Crisis Center and hosted a successful virtual orientation. Southwest Atlanta is fostering 2 facilities in the interim as the South Atlanta area rebuilds their H & I committee.

There are many events coming up around our state with trusted servants working to ensure that our newer members have a chance to learn and serve in carrying the message via our h&i panel meetings.

It was brought up in our meeting that at this time, with sub committees struggling to fill positions, there are H&I meetings taking place, iterated by groups or members. A point to consider is how the consistency and structure of H&I panel meetings, as suggested by the H&I handbook, is being assured, as well as sufficient orientation for those serving these facilities. At this time a clear NA message is of the utmost importance. Recovery Community Organizations are popping up across the state, hosting all recovery groups that blur the various program lines, offering a great yet different way to find a new way to live.


